The puppy shall remain with "The Breeder" until the puppy is at least 8 weeks old and no older than 9 weeks old unless noted in this contract.

PLEASE NOTE: Elhart K-9's will choose final puppy selection for each client after the following checklist has been completed with the puppies in this litter:

- play behaviour between littermates and interaction with the dam from birth to a minimum of 7 weeks of age.
- Independent Volhard Temperament Testing completed at day 49.
- Vet check
- Consideration of the BUYERS home situation i.e. small kids, small dogs, energy level of the client. Requests for show/breeding/working puppies. Conformation, movement, focus and drives will be considered to insure the best possible match has been determined for each client.

\*As the breeder, we reserve the right to retain pick male or female from the litter.

The deposit amount of \$400.00 is included in the total purchase price noted above. This deposit is NON-REFUNDABLE should the BUYER decide to not want the puppy/dog or be unwilling to take the puppy/dog.

Once the deposit has been paid to the Buyer, the puppy will no longer be available to any other client or the Seller.

The BUYER further acknowledges and agrees that the BUYER will forfeit the full holding fee or any other clause noted in this contract, along with any monies paid, or rights to the puppy/dog, if the buyer:

- Cancels or fails to complete the sale by the pick-up date indicated above.
- Fails to respond to three consecutive documented attempts by the Breeder to contact the Buyer regarding the puppy/dog or sale. These attempts may be made by phone, email, social media platform, messenger, or other means of correspondence.

If either of the above points occur, the Seller shall be free to immediately sell the puppy/dog to another party without refund or further obligations to the Buyer.

This puppy is sold on a limited registration in which the BUYER is responsible for spay/neutering of this pup no sooner than 12 months and no later than 2 years of age. I have read the Health Guarantee provided by the Breeder and understand the terms defined within.

BREEDER: I will accept this deposit amount of \$ \_\_\_\_\_ to hold said puppy until it is at least 8 weeks old and no older than 9 weeks old. If the puppy should no longer be available due to illness or accident I agree to apply said deposit to another available puppy from this litter, or another available/future litter. The breeder may also choose to return the deposit to "The Buyer" at "The Breeder's" discretion.
